Annual Tuition: 2018-19 Annual Tuition for Grades K-4 is **\$27,100**.

Sibling Discount: 2018-19 Annual Tuition is reduced by **\$2,750 for the second (younger) child** enrolled, and reduced by **\$5,500 for the third and each additional (younger) child** enrolled. The Sibling Discount is applied to each younger student and is only applicable when more than one child in the same family is enrolled during the same School Year.
